Can You Have a Loaded Gun in Your House in New Jersey? Yes. A person can keep and carry any legal firearm in his or her place of business, residence, premises or other land owned or possessed. Are Hollow-Point Bullets Illegal in New Jersey? Yes. Hollow-point and armor-piercing ammunition is prohibited in New Jersey.

What do I do? Can I keep it? If you do not wish to keep the firearm follow the steps above (See #22). However if you decide to keep the firearm, provided it is New Jersey compliant (i.e. not an assault weapon), it may be kept, sold or destroyed according to N.J.S.A. 2A:18-72 Disposal of remaining personal property abandoned by tenant.
